#### **SWCD Water Information 101**

The District holds water rights covering over 17,000 acres. The use of water under a water right is restricted to the terms and conditions described in the water right certificate, place of use, point of diversion or appropriation, and type of use. For example, if a water right holder establishes the right to irrigate a particular 20-acre tract of land from a specified water source, the water cannot be diverted from a different point or source, nor can it be used to irrigate other land without permission. It cannot be used for any other purpose than the type of use indicated in the water right and it must be used on covered areas once every 5 years.

The water rights are certificated to the District but are appurtenant to a landowner's property. When water rights are placed on your property, SWCD is required by law to enter into a water delivery contract with the landowner and the contract establishes the general terms of our relationship. The Contract customarily requires the District to deliver and the landowner to beneficially use irrigation water, among other terms.

If there is any situation that prevents you from using water on all areas, such as a new building, driveway, or shop facility you have a duty to report that to the district and allow us to transfer the water to keep

the water right valid. (see map example) Patrons are responsible to pay District assessments for the contract term or until a successful water rights transfer takes place. Oregon law also allows water rights to be leased as instream water rights to establish flow levels that remain in stream for fish protection, recreational use or to minimize pollution.

# Santiam Water Control District HAS ADOPTED A RESOLUTION ESTABLISHING DISTRICT TIMELINES TO WITHHOLD WATER, COLLECT DELINQUENT ASSESSMENTS AND BEGIN FORECLOSURE PROCEEDINGS

The SWCD Board of Directors has resolved to enforce water delivery withholdings and initiate foreclosure proceedings on delinquent accounts. In accordance with ORS 553.230 (6), water will be withheld starting May 1, 2023, from lands with overdue charges unless an approved payment plan is in place.

### **Key Actions:**

- **Notification**: Delinquent patrons will be informed of potential water withholding and offered a chance to arrange a payment plan.
- Foreclosure Proceedings:
  - o The resolution is transitioning from a 5-year delinquency triggering foreclosure to 3 years.
  - A 3-year foreclosure timeline is being implemented, affecting accounts delinquent from 2019 to 2022, with respective proceedings beginning from November 1, 2024, to November 1, 2026.
  - Starting with 2023, any delinquency reaching 3 years will trigger foreclosure on November 1 of that year.

This resolution ensures compliance with statutory obligations while providing options for patrons to settle their accounts and avoid foreclosure.

Assessments are due on April 15 <sup>th</sup> annually, the lands are levied in March by Board order placing a lien and the assessments are deemed delinquent on November 1 <sup>st</sup> of the same year if they have not been paid. Lands with a Board approved payment plan are deemed NOT delinquent as that term applies to withholding water.
